## Providing legal help to vulnerable farmworkers

"Maria" was a seasonal farmworker working legally in the US on a temporary work visa when she had a stroke as the result of an accident at work. The stroke left her with no use of the right side of her body. In addition to being in a wheelchair, she had memory loss and expressive aphasia, which made it difficult for her to recall words. Utah Legal Services' provided Maria with bilingual legal services to help her apply to become a U.S. citizen. Utah Legal Services worked with Maria and her doctor to submit a disability waiver so that she did not have to take the English language and civics test. The disability waiver and the citizenship application were both approved, and Maria is now a U.S. citizen.

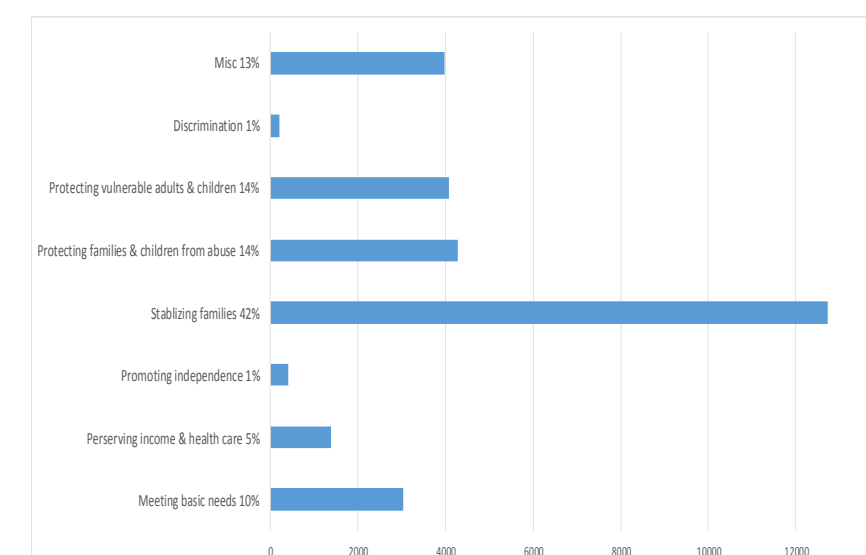


## Saying goodbye to a dear friend

Ensuring the civil rights of people with disabilities

On July 6, 2017, with representation from the ACLU of Utah and the law firm of Latham & Watkins, the Disability Law Center filed a lawsuit demanding the right to counsel for anyone who is to be put under guardianship. The lawsuit challenges a 2016 Utah law, H.B. 101, which lowered legal counsel requirements for people with disabilities who are involved in guardianship disputes. H.B. 101 states that under certain circumstances, a person with disabilities defending against a petition for guardianship brought by a parent isn't required to have an attorney. By allowing guardianships to be imposed on people with disabilities without requiring and paying for counsel to protect their interests, the suit alleges that the state of Utah violates the 14th Amendment to the U.S. Constitution, as well as the Americans with Disabilities Act (ADA) and Section 504 of the Rehabilitation Act.

She didn't know where else to turn. "Anna" came to Legal Aid Society of Salt Lake to represent her in a divorce case after fleeing her abusive husband and moving to Utah with their 2 year old son. Anna's husband "Jake" followed her to Utah and harassed her about the divorce and custody. While Anna was in the hospital for the birth of their second son, Jake took their 2 year old and refused to give him back. Anna had to call the police the day after being released from the hospital with her new-born son in order to get her 2 year old son back from Jake. Even after that incident, Jake continued to harass Anna and, in an attempt to control her, he frequently threatened to leave her in financial ruin and take the two children and move to another country so she would never see them again. Anna's Legal Aid attorney was able to negotiate a final settlement which gave Anna sole physical and legal custody of her two sons as well as financial support in the form of child support and alimony to help her move on and live free and independently with her children here in Utah.
