## **Kai Wilson Retiring After 19 Years as Executive Director for “AND JUSTICE FOR ALL”**

SALT LAKE CITY, Utah—Kai Wilson, executive director of “AND JUSTICE FOR ALL”, will retire from the organization effective March 31, 2018 with 19 years of service to the nonprofit organization that raises funds for free civil legal services in Utah. Kelly Striefel will step in to serve as interim executive director.

“Kai has provided “AND JUSTICE FOR ALL” with steady leadership during the past 19 years, and we are grateful that he is leaving the organization on solid ground,” said Daniel Barnett, Chair of the “AND JUSTICE FOR ALL” Leadership Committee and a shareholder with Parr Brown Gee & Loveless. “The community will long be indebted to him for his service and leadership with “AND JUSTICE FOR ALL” and, before that, with the Legal Aid Society of Salt Lake. Kai’s performance has been exemplary. His management and collaborative skills have helped thousands of Utahns obtain the justice they need to live productive lives. On behalf of the Leadership Committee, I thank him for his service and wish him well in retirement. He will be greatly missed.”

Wilson joined Legal Aid Society of Salt Lake as finance and development director in 2000 where he was instrumental in reorganizing and stabilizing the organization’s financial reserves. During this time, he oversaw “AND JUSTICE FOR ALL’s” finances and the Community Legal Center capital campaign, a combined effort to purchase a building and co-locate Utah’s civil legal service agencies in a single facility.

After being named executive director of “AND JUSTICE FOR ALL” in 2003, Wilson helped usher in tremendous growth in the organization. Wilson was actively involved in cultivating and building positive relationships with donors, foundations, and the legal community. Under his guidance, “AND JUSTICE FOR ALL” increased their annual campaign to over 1 million dollars a year and the organization has become one of the most respected non-profits in Utah.

Wilson retires with more than 30 years of nonprofit experience including expertise in nonprofit administration, fundraising, and program development and implementation. In addition to his work with AJFA, he has served as an executive leadership coach, a teacher through the University of Utah’s Department of Professional Education, and a consultant to other nonprofits. He previously served as an Executive Coach with the Fieldstone Foundation, on the Board and Executive Committee of the Utah Nonprofits Association, as the Treasurer of the Utah Philanthropy Day Committee, and on numerous grant review and other committees.

“AND JUSTICE FOR ALL” is a joint fundraising collaboration between Utah’s three primary providers of civil legal aid in Utah—Utah Legal Services, Disability Law Center and Legal Aid Society of Salt Lake. These three nonprofit providers offer free civil legal representation and programs that help people in Utah receive justice, protect their well-being and overcome poverty. The organization also provides funds to additional legal service agencies including Catholic Community Services Immigration Program, DNA Navajo Legal Services, Holy Cross Ministries Legal Program, International Rescue Committee, Timpanogos Legal Center, Utah Dispute Resolution, and Volunteers of America Homeless Youth Legal Clinic in 2018.
